- Handling before Cyprus Courts and obtaining on behalf of foreign entity a worldwide Mareva injunction and Norwich Pharmacal type order and gagging orders against Cyprus Bank.
- Obtaining Norwich Pharmacal/Disclosure order in aid of LCIA Arbitration proceedings and in aid of Civil proceedings in Israel. The disclosure order obtained is a hybrid order, the first of its nature in support of intended Arbitration proceedings.

Our firm representing a co-defendant within the frame of the Contempt proceedings in issue, the District Court of Limassol after hearing delivered judgment in favour of all the Defendants-Respondents the contempt proceedings therefore being dismissed and rejected.
